

## Terms and Conditions

Please note that because Flow Into Your Highest Potential Retreats are limited to a small number of attendees, to allow for a more personable, intimate experience, our cancellation policy is in place to help guests and us alike work together sharing expenses that may arise from unexpected cancellations.

### Payment Due Dates

Hold Deposit of EUR 600 is due at the time of booking.  
50% of final balance is due 120 days before retreat start date.  
The remaining 50% of the balance is due 95 days before retreat start date.  
Any refunds allowed will incur a 3% processing fee.

### Cancellation Policy

We understand that unforeseen circumstances can arise. Please read the following policy carefully, as it outlines the terms related to cancellations, refunds, and responsibilities.

### Participant Cancellations

- **95 days or more** prior to the retreat start date: All payments made will be refunded, minus a non-refundable fee of **EUR 300**.
- **94 days or less** prior to the retreat: Payments are **non-refundable**, unless you are able to find someone to take your place. In that case, we will issue a refund upon receipt of the replacement participant's full payment, minus the **EUR 300** administrative fee.

## Retreat Cancellations

- In the unlikely event that we must cancel the retreat for reasons within our control, you will receive a full refund of all payments made up to the time of cancellation.
- However, we cannot be held responsible for any additional costs incurred, such as airfare, accommodations, or other travel-related expenses.

## Force Majeure (Unforeseen Events)

In the case of retreat cancellation due to circumstances beyond our control — such as severe weather, natural disasters, epidemics, pandemics, political unrest, or other **force majeure** events — any refunds will depend on what we are able to recover from the retreat venue.

Please note: **We cannot offer compensation for airfare, accommodation, or other travel costs incurred** under such circumstances.

## Travel Insurance

No one books a retreat with the intention of cancelling, but unexpected events can happen. We **strongly recommend** purchasing comprehensive travel insurance that includes:

- **Trip cancellation/interruption coverage** (in the event of illness, injury, or emergencies)
- **Medical coverage** while abroad

This is the best way to protect your investment.

## Participant Responsibility

Flow Into Your Highest Potential Retreat is **not liable** for any personal expenses, including airfare, accommodations, or other travel costs, incurred due to changes in itinerary or retreat cancellation, **regardless of the reason**.

It is your responsibility to read and understand our cancellation policy.

We are unable to offer refunds or credits for:

- Failure to attend
- Arriving late
- Leaving the retreat early
- Incomplete participation
